We must hear from you no later than 60 days after we sent you the FIRST statement on which the error or problem appeared.

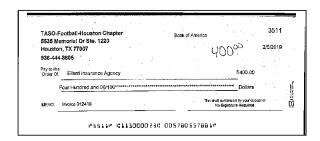
